

**SPECIAL MEETING

The Special Meeting was held at the District Office and was called to order by **CHAIR DAVID MAKIDON** at 10:00 a.m. Present for roll call were **COMMISSIONERS LINDA GRAVES, NITA HOLLEY, DAN KEES, DAVID MAKIDON and BILL NOONAN**. A quorum was declared with 5 Commissioners present.

He added that Jimmy Jones from *Heavy Constructors of Arkansas* has equipment in the area for the Hawk Drive repair, and gave a proposal to remove material above the road. Discussion continued. **COMMISSIONER KEES** moved to approve the proposal from *Heavy Constructors of Arkansas* to help mitigate the landslide in an amount not to exceed \$7,500.00. **COMMISSIONER NOONAN** seconded. Motion carried unanimously.
