12B1) Presentation on Marina Fuel System: District Manager Lawrence Blood stated that the Marina suffered a 200 gallon fuel leak in August of 2016, and since it was repaired there have been 3 smaller leaks indicating a larger issue. He introduced Jerry Barns and Steve Grant from Mid-State Petroleum Equipment (MSPE), to discuss the issues. MSPE indicated that we have old piping which historically has been problematic. They recommend replacement with a double wall stainless steel piping (30 year limited warranty).
