

## REGULATION NO. 2026-R2

### A REGULATION AMENDING CHAPTER 8 OF THE CODE OF REGULATIONS OF THE HOLIDAY ISLAND SUBURBAN IMPROVEMENT DISTRICT TO ESTABLISH MITIGATION RATES FOR FIRE DEPARTMENT SERVICES INVOLVING HOLIDAY ISLAND RURAL FIRE PROTECTION DISTRICT RESPONSES

---

**WHEREAS**, the Holiday Island Suburban Improvement District (“HISID” or “District”) is obligated to respond to rural emergencies pursuant to Carroll County Ordinance Nos. 2002-003, 2002-016, 2012-003; and it is therefore in the best interest of HISID property owners that the District comply with these ordinances to mitigate potential legal exposure; and

**WHEREAS**, the HISID Fire Department continues to experience increasing demand for emergency and non-emergency services; and

**WHEREAS**, such responses require personnel, equipment, training, and operational readiness that create ongoing costs to HISID; and

**WHEREAS**, it is inequitable for HISID property owners to bear the full financial burden of services rendered outside the boundaries of HISID, and it is therefore in the best interest of HISID property owners that the District recover costs associated with responding to rural emergencies; and

**WHEREAS**, the Board of Commissioners finds it appropriate to establish a fair and reasonable cost recovery system for services provided within the Holiday Island Rural Fire Protection District boundary.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE HOLIDAY ISLAND SUBURBAN IMPROVEMENT DISTRICT, ARKANSAS:**

#### SECTION 1

Chapter 8 – Fire Prevention and Protection of the Code of Regulations of the Holiday Island Suburban Improvement District is hereby amended to include the following:

---

### **Sec. 8-34 – Fire Department Mitigation Rates – Holiday Island Rural Fire District Responses**

(a) The Holiday Island Suburban Improvement District Fire Department is authorized to establish and implement mitigation rates for the delivery of emergency and non-emergency services provided **outside the boundaries of HISID**, specifically within the **Holiday Island Rural Fire District boundaries**.

(b) These mitigation rates shall apply only to:

- Incidents occurring outside HISID’s boundaries; and
- Non-district residents, non-taxpaying properties, or entities not subject to HISID fire protection assessments.

(c) No mitigation rates shall be charged under this section for:

- Incidents occurring within the boundaries of HISID; or
- Holiday Island residents or property owners currently paying HISID assessments for fire protection services, unless otherwise required by law, or
- Holiday Island Rural Fire District volunteer firefighters or Holiday Island Rural Fire District residents who are current on their annual dues for fire protection services paid through the Holiday Island Rural Fire Department, unless otherwise required by law.

(d) Mitigation rates shall be based on actual costs and those deemed usual, customary, and reasonable (UCR), and shall include personnel, equipment, supplies, and administrative costs associated with the response.

(e) Claims shall be submitted to the responsible party(ies) through their insurance carrier when applicable. In certain circumstances, the responsible party(ies) may be billed directly.

(f) The Board of Commissioners may adopt, amend, or revoke rules and procedures necessary for the administration and collection of mitigation rates.

### **SECTION 2 – RATE SCHEDULE**

The mitigation rates shall be set forth in **Exhibit A**, attached hereto and incorporated herein by reference. The rate schedule may be updated periodically to reflect actual costs and industry standards.

---

### SECTION 3 – ANNUAL ADJUSTMENT

Mitigation rates shall be adjusted annually based on the Consumer Price Index (CPI) as published by the U.S. Department of Labor, Bureau of Labor Statistics. Adjustments shall occur on the anniversary date of adoption.

---

All Regulations, Resolutions, or Orders of the Holiday Island Suburban Improvement District, or parts of the same, in conflict with this Regulation are repealed to the extent of such conflict.

#### GENERAL STATEMENT

The mitigation rates below represent average billing levels based on typical incident responses. Actual billing may be itemized and reflect the specific personnel, equipment, and materials used.

Rates are based on actual costs including apparatus, labor (wages, benefits, retirement, insurance), equipment, maintenance, and consumables.

#### MOTOR VEHICLE INCIDENTS

Level	Description	Rate
Level 1	Hazardous materials assessment and scene stabilization	\$618.00
Level 2	Includes Level 1 + hazardous fluid cleanup and disposal	\$705.00
Level 3 (Car Fire)	Fire suppression, rescue tools, foam, and cleanup	\$860.00

#### Add-On Services

Service	Description	Rate
Extrication	Use of rescue tools, airbags, cribbing, etc.	\$1,859.00
Landing Zone	Helicopter landing zone setup and coordination	\$567.00

#### HAZMAT INCIDENTS

Level	Description	Rate
Level 1	Basic response, perimeter, evacuation, command	\$999.00
Level 2	Hazmat team, protective suits, decontamination setup	\$3,566.00

Level 2	Includes Level 1 + minor hazardous cleanup	\$1,170.00 + \$70/hour per rescue person
Level 3	Advanced response, hazmat support, decon	\$2,897.00 + personnel hourly rates
